Additionally, establishing and maintaining corporate policies and procedures, and ensuring appropriate levels of insurance for the associations and its directors and officers.

## **Term & Fee**

KW Consulting proposes an initial term of 12 months. At this point the NSITSP and KW Consulting can reevaluate the scope of services to determine the needs of the organization and board of directors moving forward.

KW Consulting proposes a flat monthly rate of \$3,500 for full association management services outlined in the management plan. The proposed initial term is for 12-months for a total contract fee of \$42,000, plus reimbursement for pre-approved expenses.
